SUPERINTENDENT'S REPORT

March Student of the Month

Dr. Sefcik announced the March Student of the Month, Dominick Tadewald. He was unable to join us in person for the meeting so she read his profile of accomplishments that included academic achievements, extracurricular activities, service to his community, his Boy Scout successes, what he enjoys in his spare time, and his future plans. Since he couldn't be in attendance, he provided a video that voiced his pride at being chosen and he thanked Dr. Sefcik and the Board for all they do for students.

Excellence in Education Award – 3rd Quarter

Dr. Sefcik recognized Max Boton and congratulated him as this quarter's recipient of the Excellence in Education Award, and asked Principal Schmidt to introduce him to the Board. Mr. Schmidt read the narrative from the peers that nominated Max on the reasons why he deserves the honor. The Board applauded and thanked Mr. Boton for his substantial contribution to the students and staff of Grant. Mr. Boton said he was honored to be chosen as the Excellence in Education Award winner and he also mentioned that Dominick Tadewald was an excellent choice for Student of the Month. The Board applauded and thanked Mr. Boton for his service to Grant High School.

Blended Learning Plan Update

Dr. Sefcik was excited to announce the return of the District's original Blended Learning Plan that allows for students to return to two days in person per week. Due to the revised public health guidance from the Illinois State Board of Education and the Illinois Department of Public Health, guidelines have been modified to lessen the barriers for in-person learning. Specifically, social distancing is now defined as 3-6 feet and capacity limits in a space are now determined by the ability to social distance rather than a previous set limit of 50 individuals per space. Additionally, community transmission continues to decline. We will implement these changes beginning March 29, 2021.

At the request of the Board, Dr. Sefcik investigated whether it was possible to increase in-person learning beyond two days per week. The administration reviewed in-person attendance numbers in detail and functional capacity of classrooms to accommodate an increased number of students while still abiding by new social distancing requirements. Additionally, areas to accommodate 6' of social distancing while eating were investigated and creative options identified. Dr. Sefcik presented options to the Board of Education to increase in-person learning to four days per week. Mr. Hill made the recommendation we transition to full in-person learning for students that wish to attend in-person beginning on Monday, April 12. Students will attend on Mondays, Tuesdays, Thursdays and Fridays. Wednesdays will be retained as a flex schedule day with all students learning at home and deep cleaning taking place on those days. Given that there will only be a few weeks left in the school year when we make the transition to full in-person learning, we are asking teachers to continue teaching synchronously each period, with students learning both inperson and at home. She and the Board recognized the incredible job the teachers have been doing despite all the difficulties in teaching for both in-person and remote learners.

A motion was made by Mr. Yanik, second by Mr. Jared to approve the transition to full inperson learning for students that wish to attend in-person on Monday, Tuesday, Thursday, and Friday, beginning on Monday, April 12, 2021. Wednesday will still be flex schedule days, with no students attending in-person learning.

Assessments that will remain required are SAT for grade 11, Dynamic Learning Maps (DLM) Alternative Assessment, ACCESS for English Learners, and Illinois Science Assessment. The PSAT for grades 9 and 10 is no longer required and will not take place. When additional information is received, it will be communicated.

Principal's Report

Mr. Schmidt presented his monthly report which included information on End of Semester Information, Summer School, Foreign Language Overseas Trip Planning, Feeder Principal Articulation, Looking Ahead to 2021/22, and Blood Drive.

BUSINESS AFFAIRS

Summer School Recommendation

Mrs. Reich reported that we offer summer school each year consisting of enrichment courses to credit recovery courses. This summer we anticipate greater enrollment to recover credits due to students struggling with blended and remote learning. Some of the changes recommend offering supplemental learning opportunities and expanding the access to students and their families. She recommended providing additional courses and additional teachers which will allow the District to expand summer instructional opportunities. In addition, waiving the \$130 cost to families for credit recovery summer school during the Summer 2021 program. Lastly, in an effort to recruit more teachers for the summer course offerings, increase the 2021 summer school hourly pay from \$50.16/hr. to \$76.33 per hour.

IHSA Update 4/12/21

The Board approved a recommendation from the IHSA Financial Ad Hoc Committee to implement an annual membership assessment over the course of the 2021-22, 2022-23, and 2023-24 school years. Known as the IHSA Recovery Plan, the graduated fee structure is based on a school's enrollment, which is generally a strong indicator of participation in IHSA sport and activity programs. Assessments for the 2021-22 school year will be collected through September 1, 2021. The graduated assessment structure is as follows:

IHSA Executive Director Craig Anderson:

"The IHSA Board does not make this decision, or for that matter, any decision that has a fiduciary impact on our member schools lightly. The pandemic has obviously been unprecedented and the financial impact on the Association immense. The large majority of the IHSA budget is derived from gate receipts from postseason tournaments, most of which have been canceled or void of fans for the past year or longer. Meanwhile, our mission has continued, as we maintain the majority of our day-to-day responsibilities for our membership, while also continuing to conduct many state tournaments in virtual formats with an increasing emphasis on returning to in-person events when possible. We have been open and transparent with our member schools about our financial standing and the cuts and freezes we have and continue to make in order to be as fiscally responsible as possible. Our financial ad hoc committee was representative of a diverse group of schools from around the state, and they discussed a number of different budgetary options. They were unanimous in their decision that they believed the best option was the membership assessment fee structure approved today by our Board. It is important to note that the IHSA Recovery Plan will be reevaluated over the next three years. If we are able to reduce or eliminate future assessments, then we will look to do so. We remain grateful and appreciative of all the support our member schools have provided us as we have navigated the uncertainty of the past year."

Bills Here, There and Everywhere

There's a line from a children's book that reads, "Here, There and Everywhere" that feels fitting to describe the deluge of bills still in play this legislative session.

At last check, the House had 671 bills on its floor calendar and the Senate had 234. The bills are at various stages of the legislative process, with some having been approved by committees, others awaiting hearings and many bills expected to return to committee with an amendment.

At this point, IASA continues to have numerous conversations with bill sponsors and is closely monitoring legislation. We will keep you informed on changes, developments and provide alerts on when we need to push hard and make our voices heard.

For this Capitol Watch, I want to give you a larger sampling of what has been introduced. Trust me, the list is even longer than what we write about here.

As part of the tidal wave of proposals we're seeing this session is an uptick in curriculum mandates. IASA is currently tracking 24 possible curriculum mandates. Click here to view the complete list.

If you watched IASA Executive Director Dr. Brent Clark's conversation with Illinois Speaker of the House Emanuel "Chris" Welch, the new Speaker mentioned he has "never been a big supporter" of unfunded mandates. Also in the conversation, Speaker Welch listed three top priorities for the 102nd Illinois General Assembly: Redistricting, a responsible budget and ethics reform to rebuild trust. Conference registrants can access the interview in the Virtual Attendee Hub.

Speaking of the budget, we won't likely know until closer to the end of the session how everything will shake out. The American Rescue Plan provides \$7.5 billion for the state of Illinois. The dollars will need to be used to pay off short-term borrowing, fill the budget hole and address pandemic recovery efforts, among other things.

The federal relief package also includes \$5 billion for K-12 schools in Illinois. Gov. JB Pritzker has proposed using federal funds to provide additional support to schools and keeping Evidence-Based Funding flat. Interestingly, a number of high-ranking lawmakers have been outspoken against the governor's EBF plan.

The General Assembly has six weeks of session remaining until the May 31 adjournment. The Senate will be spending the majority of its time this week in committee hearings as its committee deadline was extended to Friday, April 16. The House also continues to hold hearings. While at the same time, the substantive deadline for bills to pass out of their chamber of origin is April 23. As Rich Miller at the Capitol Fax put it, "The Slog Continues."

We don't usually make Capitol Watch this long, but I wanted to give you a more detailed breakdown of legislation we're tracking. The following bills are listed numerically.

House Bills

Forced School Consolidation, Rep. Rita Mayfield (D-Waukegan)

HB 7

As we have detailed previously, IASA strongly opposes HB 7. The goal of the legislation is to reduce the statewide total number of school districts by no less than 25% through the reorganization of high school and elementary districts into unit districts.

Two amendments have been filed by the bill sponsor that make minor adjustments to the original bill. The makeup of the task force would change slightly, and the timeline of when the recommendations would go to referendum is pushed back to the 2024 election.

IASA is not opposed to districts consolidating, but we believe strongly it has to be a community-initiated plan that is supported by incentives offered by the state. Otherwise, it is highly likely that forced consolidation will lead to a significant increase in costs at the local level. The primary driver of that is the merging of salary schedules but increased transportation costs and additional facility needs can also arise.

Substitute Teachers, Rep. Sue Scherer, (D-Decatur)

HB 21

The legislation provides some relief for school districts experiencing a shortage of substitute teachers. The bill allows a Teacher Retirement System annuitant to substitute teach without restriction in school districts that have been granted a waiver of the days and hours restrictions.

The bill provides that a school district may apply for a waiver by providing sufficient evidence there is a substitute teacher shortage in the school district and an estimate of the number of paid hours in the school year that the annuitant will work.

Special Education Age, Rep. Frances Hurley (D-Chicago) HB 40

The legislation would allow special needs students to receive special education services through the end of the school year that they turn 22 years of age. The current law says students are eligible for special education services until the day before his or her 22nd birthday.

Two major concerns are the cost and impact on staffing levels. At a committee hearing last month, one estimate said the bill could cost up to \$20 million more than the status quo for the state and school districts.

Paid Sick Leave for Birth or Adoption of a Child

HB 75 Rep. Mary Flowers (D-Chicago)

HB 816 Rep. Michelle Mussman (D-Schaumburg)

HB 75 amends the Illinois School Code to say for purposes of calculating paid sick leave for the birth of a child or the adoption or placement for adoption of a child:

- The days do not have to be taken immediately after the birth of the child or the adoption or placement of the child.
- The days do not have to be taken consecutively.
- The school board may not count any day in which school is not in session, including an extended break.

HB 816 is a similar proposal, but instead provides that up to 30 days of paid sick leave days may be used by teachers for birth/adoption of a child. The days do not have to be taken consecutively and non-working days do not count.

Menstrual Hygiene Products, Rep. Barbara Hernandez (D-Aurora) HB 156

The proposal requires school districts to place menstrual hygiene products in every bathroom of every school building.

Two amendments have been filed since the bill was initially introduced. House Amendment 1 adds feminine wipes to the list of feminine hygiene products. House Amendment 2 replaces "each bathroom of every school building" with "bathrooms of every school building that are open for student use in grades 4 through 12 during the regular school day."

Absences for Religious Reasons, Rep. Daniel Didech (D-Buffalo Grove) HB 169

The proposal provides that a child may be absent from a public school because of religious reasons, including the observance of a religious holiday or participation in religious instruction.

HB 169 also requires superintendents to develop and distribute information about absence for religious purposes, how the school should be notified by parents and the process for making up school work missed.

School Wide Behavioral Interventions Grant Program, Rep. Jonathan Carroll (D-Northbrook)

HB 219

Discussions are ongoing with the bill sponsor and advocates on HB 219.

The legislation would prohibit the use of "prone restraint," in which a person is held face-down on the floor or other surface while pressure is applied to the student's body to keep him or her in that position, as well as mechanical and chemical restraint.

The bill also provides that timeouts, isolated timeouts and other forms of physical restraint could only be used when the student's behavior poses an "imminent danger of serious physical harm to the student or to others," and it would direct the Illinois State Board of Education to develop a plan for greatly reducing the use of those practices over the next three years.

In addition, the legislation requires ISBE to create a grant program for schools to implement school-wide behavioral interventions.

Media Literacy Curriculum, Rep. Elizabeth Hernandez (D-Cicero)

HB 234

Beginning with the 2022-2023 school year, the proposal requires every public high school to include in its curriculum a unit of instruction on media literacy.

Sex Education

HB 1736 Rep. Kathleen Willis (D-Northlake)

HB 3071 Rep. Camille Lilly (D-Chicago)

We grouped these bills together because both focus on sex education curriculum.

HB 1736 mandates that a comprehensive, standards-based sex education course be taught in preK through 12th grade, including school disclosure, parental requests and notice of program. The bill allows school districts to collaborate with public health departments to identify a point of contact for inquiries and comments about course instruction and materials.

HB 3071 provides that school districts providing sex education are required to deliver a standards-based evidence-informed curriculum.

Substitute Teaching Licenses, Rep. Will Davis (D-Homewood) HB 1874

The legislation is a step in the right direction in addressing the teacher shortage. The proposal makes the usage of Short-Term Substitute Teaching Licenses permanent in teaching content-areas where teacher shortages exist.

Faith's Law, Rep. Michelle Mussman (D-Schaumburg) HB 1975

IASA and other school stakeholders continue to have numerous negotiations on HB 1975.

The proposal has garnered significant attention and has been given the name, Faith's Law. The bill would make it mandatory for schools to develop a sexual misconduct code of conduct, review employment histories and teach students about grooming and sexual misconduct in sex education. The legislation would allow for schools to set up two days of in-service learning for teachers to train on identifying such behavior and set up a resource guide on sexual abuse for parents. The bill also adds grooming and aggravated criminal sexual abuse to criminal sexual assault offenses in the Criminal Code.

In-Person Instruction Guidelines Next School Year, Rep. Michelle Mussman (D-Schaumburg)

HB 2789

IASA, along with other stakeholders, continues to be in negotiations with the bill sponsor, Illinois Education Association and Illinois Federation of Teachers on HB 2789.

House Committee Amendment 1 states the Illinois Department of Public Health shall establish metrics and develop recommended guidelines for school districts and public institutions of higher education to use during the public health emergency in determining if the district or institution may safely conduct in-person instruction or if the district or

institution must implement remote learning or blended remote learning to keep students and staff safe.

In addition, the proposal requires school boards to bargain and negotiate procedures for implementing safety procedures and protocols.

Also included in the amendment is language that says the board shall grant an employee of the district paid sick leave if the employee contracts COVID-19, but only if the employee has used the full amount of paid sick leave already allotted to the employee and the employee provides medical documentation.

Energy Conservation Contracts, Rep. Joyce Mason (D-Gurnee) HB 3149

The legislation limits the period of time that guaranteed energy savings contracts can be in place from 20 years to eight years.

The proposal also makes other changes, including requiring regional superintendent approval, defining what "energy conservation measure" does NOT include, defines allowed energy operating costs, requires submission to the State Capital Development Board Procurement Bulletin for publication, requires performance reviews every four years and disallows any new or modified contracts after Jan. 1, 2026, ending the program.

Gender-Based Violence, Rep. Anna Moeller (D-Elgin) HB 3223

Rep. Moeller's bill would allow a student who is a victim of gender-based violence to transfer schools immediately if the student's continued attendance at the original school poses a risk to the student's mental or physical well-being or safety. It also provides that a student's disclosure of his/her status as a parent, expectant parent or victim of genderbased violence be a mitigating circumstance in any suspension or expulsion proceeding. Many other requirements for school districts are also included affecting homebound instruction, student absences/truancy, staff training, review/revision of policies and procedures, complaint procedures, confidentiality and student accommodations and services.

Remote e-Learning Days, Rep. Thomas Bennett (R-Pontiac)

The proposal allows school districts to use remote e-learning days for emergency days. Provides that the number of remote learning days used in a school year may not exceed the number of emergency days provided for in the school calendar and the district superintendent must approve a remote learning plan for the district before the district may utilize a remote learning day.

Senate Bills

Absenteeism and Truancy Notification, Sen. Jacqueline Collins (D-Chicago)

The proposal requires that each school district, charter school, alternative school or any school receiving public funds develop an absenteeism and truancy policy to be communicated to students and their parents or guardians on an annual basis.

Shared Superintendent Services, Sen. Sue Rezin (R-Morris)

SB 1637

SB 1637 is an ill-advised proposal we have seen before. The bill attempts to give voters the authority to force their locally-elected school boards into resource-sharing agreements with other districts.

The legislation amends the school code to say that if at least 8 percent of the school district's voters in the last consolidated sign a petition to share the services of a superintendent or other administrator it triggers a referendum.

IASA opposes this bill because it strips away local control from school boards and puts the decision to voters, who likely are not as educated about school matters as their locally elected school board.

This bill goes beyond stripping away local control. Superintendents manage millions of dollars and many are also asked to serve as principal as well. Unnecessarily forcing one superintendent to run two large businesses is likely going to result in additional compensation or the hiring of additional administrative staff.

Furthermore, the proposal forces districts to do something they already have the ability to do. Twenty-eight districts (14 superintendents) in Illinois have entered into shared service agreements because they decided it was best for their communities. That number is up from 22 districts in 2019. In addition, there are around 120 superintendent/principal positions in Illinois currently.

Financial Literacy, Sen. Meg Lougran Cappel (D-Plainfield) SB 1830

Senate Bill 1830 would allow either one year, or a semester, of a financial literacy course to count toward the math requirement to graduate high school.

Sunset Date for Retired Teachers, Sen. Patrick Joyce (D-Park Forest) SB 1989

The proposal extends the sunset date to 2023, allowing retired teachers to return to work up to 120 days or 600 hours per year without impairing retirement status.

Suspensions and Expulsions, Sen. Christopher Belt (D-Cahokia) SB 2088

The proposal directs school districts without alternative programs in place to create an educational continuity plan for suspended and expelled students. An educational continuity plan must provide the student with:

- A minimum of 5 hours of instruction on each day of suspension, with a minimum of 2.5 hours being synchronous with a licensed teacher.
- Access to support services provided either by the school district or an outside entity.
- Access to school meals as required under the School Breakfast and Lunch Program
 Act, provided the school district is not required to provide transportation for this
 purpose.

ISBE Data Collection, Sen. Belt

SB 2091

Beginning with the 2021-2022 school year, the legislation requires ISBE to collect certain student discipline data, including referrals and transfers to alternative schools, law enforcement and school-based arrests. It also sets forth provisions regarding school discipline improvement plans and for the ISBE to convene an Equitable and Restorative School Discipline Advisory Council.

SB 2109

This proposal requires school board members and administrators to annually complete a course of instruction on the adoption of trauma-informed school standards. By no later than December 1, 2021, ISBE is required to approve one or more courses of instruction that satisfy the training requirements.

Family and Medical Leave, Sen. Melinda Bush (D-Grayslake) SB 2547


Under this bill, an employee of a school district, public university or community college district who has been employed for at least 12 months, and who has worked at least 1,000 hours in the previous 12-month period, shall be eligible for family and medical leave under the same terms and conditions as leave provided to eligible employees under the federal Family and Medical Leave Act of 1993.

Principal's Report Board of Education April 2021

SAT Preparation Class

The 2021 SAT Preparation Class concluded the week of April 12. This year the program was modified to reach more students and improve effectiveness. Moving away from the blended model of partially Grant teacher instruction and partially Khan Academy-generated coursework, Grant partnered with College of Lake County Associate Professor Mrs. Sandy Martinez to teach Grant's 2021 SAT Prep Class.

The curriculum utilized the *College Board's Official SAT Study Guide* textbook and was taught fully remotely using Schoology as the learning management platform. Students received a total of 18 hours of instruction through six, three-hour classes. Four sections of the course ran accommodating 71 students and cost \$80. Student participation was strong throughout the course, feedback has been positive, and we will evaluate the program to consider continuing it in the future.

Assessment Updates

Like every other spring, this year's spring testing season has been busy testing a wide range of students for a variety of reasons. The largest and most complicated administration was the SAT to all juniors. This is the fifth year of the State-mandated SAT assessment for juniors. The State-wide testing day was April 13. We are pleased with our administration of the exam, as our processes for test distribution, administration, test collection, and accommodations were generally smooth with no irregularities despite COVID-related restrictions. Attendance was down from previous years but strong considering the circumstances. 377 tests were administered. The completed assessments have already been accounted for, boxed, and mailed back to the State.

Additionally, this year English Language testing is also happening in the spring and was conducted the week of April 19. Again, COVID-related limitations altered traditional testing procedures, but this in-person test is required of all 63 EL designated students. Testing is scheduled to conclude on April 23. All tests are administered by EL department staff and overseen by Area Administrator, Veronica Lukemeyer.

Lastly, the Foreign Language Department is conducting the annual 8th grade placement testing remotely this year in conjunction with feeder school principals and 8th grade teachers. Instead of the in person testing at Grant and at feeder schools, the test will be administered remotely during assigned periods, minimizing COVID-related risks while still allowing Grant staff to place students at the highest, most appropriate level upon entering freshman year.

After all of this testing, there is a quick turnaround, as we are now actively preparing to administer Advanced Placement Testing throughout May.

Student Recognition

There are several student recognition ceremonies and events of note. First and foremost, 136 freshmen have received their academic numerals and been recognized in a congratulatory video. These freshman students, despite the challenges of remote and blended learning, have thrived academically and earned a GPA of 3.75 or better in their first semester at Grant. This is an excellent start for these students, and we are excited to see them flourish throughout their next four years.

Additionally, Brei Panares and Priya Audipudy were honored as Grant's representatives at the annual Illinois Principals' Association Student Recognition Breakfast. Both Alexis and Brei have made significant impacts on the students and staff at Grant. They are extremely proud Bulldogs who are excellent models for their peers, and therefore were easy choices of students to represent Grant to other Lake County principals.

Lastly, Grant's chapter of the National Honor Society inducted 25 new members into its ranks. A formal ceremony is being planned for this summer. As a school, we are proud of these new inductees who are committing to improving our school community through scholarship, leadership, service, and character. These students must maintain a 3.5 gpa, pass all classes, grow in leadership, and serve as role models to maintain their membership.

Safety Week

Every school year, the State of Illinois requires that school districts carry out multiple safety drills including a bus evacuation drill, severe weather/shelter-in-place drill, active shooter/lockdown and an evacuation drill. This year, the required drills will take place the week of April 26 during TEAM. The Active Shooter/Lockdown drill will take place on an asynchronous teaching day without students on campus. The Bus Evacuation and Severe Weather Drills will be teacher demonstrated and/or video recorded to limit the amount of person to person contact. The Evacuation Drill (Fire Drill) will be conducted in its traditional format in coordination with the Fox Lake Fire Department.

Contact Tracing

The COVID-19 Contact tracing team has ramped up its diligent efforts as more students returned to in-person learning on April 12. This is particularly noteworthy as two of the team members are responsible for traditional Nurse Office responsibilities which have fully resumed with more students back on campus. We have been fortunate to have tracked only five (5) staff cases since April 12 bringing the total number of staff case files to 218. Tracking student case files has remained steady with 21 students tracked since April 12 bringing the total number student case files to 410. Through thousands of individual conversations and attention to ever-evolving protocols, this team's efforts have helped to manage the spread of COVID and help keep our school community safe.

Student Activities

Despite the uniqueness of the year and COVID restrictions, there are a multitude of student activities kids are engaged in to wind down the year.

- This year all grade levels of students are participating in the ABC Countdown; seeing students dressed up in person as well as posting online is a festive way to wrap up the final weeks of school.
- The freshman class is hosting a Book Drive to collect and redistribute lightly used books to families in our community
- This year's Variety Show has gone virtual. All student submissions have been prerecorded, submitted, and are being edited together. With so many tech-savvy and talented Bulldogs, everyone is eagerly anticipating a show like no other.
- The PBIS Team, with support from the Lake County Health Department, is hosting our annual Wellness Fair. The fair will be virtually run during Physical Education classes, and students will have several topics to choose from that have been researched and developed by students, staff and community members. Students will engage in the fair's activities and have a chance to win bragging rights and PBIS-prizes.

Background:	

Grant Community High School provides bus transportation to students to and from school during the regular school year. Traditionally every summer, we offer transportation to students enrolling in our Summer Academy portion of summer school. This is incoming freshmen students who benefit from added reinforcements in English, math or both. Transportation consists of four buses that run the four geographic quadrants, North, South, East and West, as per our after school activity routes. Under the COVID-19 pandemic restrictions, each bus can hold 49 students and one driver. For summer of 2021, we anticipate a greater need of summer school for more students.

Last month, the Board approved the waiver of fees for the credit recovery courses for students who have struggled during remote/blended learning. This month, we are recommending an additional operational expense in order to meet the instructional needs of students. We are proposing to add a no-cost transportation option for all students enrolling in summer school.

Possible Solution:

In determining a possible solution, we considered our routes that we run every summer for Summer Academy students. As those routes are already planned for this summer, for students enrolled in Summer Academy, it is logical to apply them to all students enrolling in summer school. In a normal summer, not all students who are enrolled in Summer Academy need bus transportation. The start/end times for Summer Academy mirror the start/end times of all other summer school. Knowing we are running those routes and that not all students enrolled need transportation, we determined there will likely be room on those buses for students who are enrolled in other summer school classes. Our current routing of four buses with 49 students per bus has room for 196 students. If we added an additional four buses, running the same activity routes, it creates opportunity for an additional 196 students to get to Grant for summer school.

In looking at the additional four buses, the costs that the District would incur consists mainly of the bus driver compensation and additional fuel. We met with Debbie Carole, Director of Transportation to discuss the additional routes and whether drivers would be willing to do this additional run. The additional time would be no more than 4 hours per day, per driver, to allow for all the stops included on the quadrants, round-trip. Based on the average driver hourly compensation at \$23.43, for four additional drivers running the summer school routes for 24 days, the additional cost to the District would be \$8,997.12. This is a high estimate of what the cost to the District would be for this service. Once we know the full enrollment for summer school, and if students need transportation or not, we will have a more concrete number. Debbie has confirmed she has drivers who are willing

to take these additional	l routes on for the summer.	

Recommendation:	

We are recommending that Grant Community High School #124 offer additional summer school transportation for Summer 2021, with a maximum of eight buses/drivers per day.
