A Regular Meeting of the Board of Education of Grant Community High School District 124, County of Lake, State of Illinois, was held on Thursday, January 21, 2021 and called to order at 7:00 p.m. in the Library of Grant Community High School, 285 E. Grand Avenue, Fox Lake and via Zoom meeting link.

SUPERINTENDENT'S REPORT

Student Recognition

Dr. Sefcik introduced the January Student of the Month, Landon Klecka, who was accompanied by his parents, Randy and Janna. She read his profile of accomplishments, which included academic achievements, extracurricular activities, service to the community, leadership roles and awards, what he does in his spare time, and future plans. Dr. Sefcik offered Landon the opportunity to speak to the Board and Landon thanked Dr. Sefcik for the honor and he thanked the Board for the opportunities afforded to students. The Board applauded Landon and Dr. Sefcik presented him with the certificate to commemorate being chosen as the January Student of the Month.

Blended Learning Update

Dr. Sefcik told the Board how exciting it was to welcome students back to blended learning on January 19, 2021. The average number of students attending the first few days was between 250-275 per day. Things have been going smoothly and teachers have been encouraged to share what's going well and what's not. She acknowledged that teaching both in-person and online is not perfect. However, there is great value in having students in-person, engaged and better able to make connections with teachers.

Dr. Sefcik also updated the Board on the status of the vaccines for Grant staff. She has been a participant in a 5-member planning pod for the District 116 vaccine site. The rollout for Phase 1b will be coming soon with vaccines beginning in at least 3 different locations the first week of February.

Assessment Update

Dr. Sefcik informed the Board that districts are still expected to administer the federally required assessments this school year. The plan and schedule to accomplish the administration of the required tests were provided. The Illinois State Board of Education recently announced that the window for particular assessments was pushed back in response to requests from school districts. The dates are as follows assuming we are still in blended learning:

- ACCESS test for English Learners will take place between March 15 and May 25.
- Illinois Science Assessment for juniors will take place between March 15 and May 14.
- Dynamic Learning Maps Alternate Assessment will take place between March 15 and May 14.
- SAT for juniors (and some seniors) will take place on April 13; this will be a state testing date with no other students in attendance.
- PSAT 10 for sophomores will take place on April 14. Wednesday's are flex days and no other students will be in attendance.
- PSAT 8/9 for freshmen will take place on April 21. Wednesday's are flex days and no other students will be in attendance.

Event Planning

Dr. Sefcik provided some information on decisions that were made for several events that happen during the year. Eighth grade enrollment night is going virtual with the primary focus on academics. The Spring Musical has been changed from *Seussical the Musical* to *Peter Pan* in order to better fit with the restrictions and mitigations to produce in a remote/virtual setting. The foreign language spring break trips to France and Spain had to be cancelled and unused travel vouchers were purchased by the district for future student travel. The prom venue for this spring was cancelled and many are working on creative ideas that will be primarily senior focused. Graduation is being reimagined to create a graduation experience that celebrates our students. Updates will continue to be conveyed to the Board.

Senior Recognition Planning

Dr. Sefcik recognized that this will be the second year in which the end-of-the-year events have had to be cancelled or reimagined. Principal Schmidt and Dr. Sefcik have met with a committee of senior parents and administrators to plan senior recognition events and acknowledge the hardships they have gone through. The goal of the committee is to express appreciation to seniors for their resilience and plan senior recognition events. They are eager to begin their first recognition event, the postcard writing campaign. They will have a different event each month leading up their May graduation.

Legislative Update

Dr. Sefcik updated the Board on the Education Omnibus Bill that the legislature recently approved and is waiting on the Governor's signature. Some of the impacts of the bill are graduation requirements to be more aligned with college entrance requirements, require two years of foreign language, a computer science course, and an update to social studies curriculum.

DMGroup Contract 2021/22

Dr. Sefcik proposed to continue to partner with DMGroup through the 2021/22 school year. With the pandemic and all efforts focused on teaching and learning remotely, the partnership with DMGroup transitioned from developing/refining a Multi-Tiered System of Supports to the immediate need of supporting struggling students in the remote environment. As a result of this change, the District temporarily paused on the MTSS framework design. However, Dr. Sefcik shared that completing and implementing the MTSS framework remains critical. She recommended the District continue to partner with DMGroup through the 2021/22 school year at a cost of \$70,000 to complete a cohesive MTSS structure.

A motion was made by Mrs. Fleming, second by Mr. Jared to approve the contract with DMGroup through the 2021/22 school year at a cost of \$70,000.

Student Residency Procedures

Dr. Sefcik recommended a 3-year agreement with Thomson Reuters, a subscription-based residency validation program, to provide us with the opportunity to verify residency, through reliable public and proprietary information prior to enrollment and periodically throughout the year. The cost is \$549.05 per month, which works out to \$6,588.60 per year.

Dear Colleagues:

Over the past several months, the members of the Board and I have been deeply engaged in dialogue about spring assessments. We have closely monitored the status of district learning models and your concerns about the social and emotional wellbeing of our students, as the pandemic has stretched on for longer than a year. While 77 percent of school districts are offering some in-person instruction, our data tell us that more than a million students are still learning completely remotely. Fewer than 200 districts serving less than 200,000 students are currently able to provide fully in-person instruction.

Given where we are, we believe it is more important to focus on supporting our students' transition back to in-person learning, than to focus on assessments. Our focus belongs on building our students' reconnection with their teachers and re-engagement in learning in the classroom. That's why we will advocate for the U.S. Department of Education to make waivers available for spring 2021 assessments. If a waiver is made available, Illinois will apply for it.

Assessment – the practice of collecting evidence about student learning to provide them with feedback and inform instructional design – is still critically important to helping students recover from the pandemic; this practice can and should happen this spring at the classroom and district levels.

It has been a collaborative process to come to this decision. We have listened and given great consideration to every perspective that has been shared with us. Thank you for your passion and your partnership on behalf of Illinois' students. Together, we will overcome this pandemic.

Dear Acting Secretary Cardona:

The below 674 superintendents representing 1,260,397 students across the great State of Illinois write to you to respectfully request a waiver of mandated state assessments for 2021.

We welcome accountability. We hold ourselves, our districts, and our students to high expectations which we measure locally using data that yields more timely information, better informs teaching and learning, and is more relevant to our students and their families. In normal times we also fully comply with regulations including annual state testing.

However, we have concerns regarding our ability to administer assessments in the midst of a continuing unprecedented global pandemic. For example:

- Illinois requires school districts to offer remote learning to families upon request. Data reported by school districts to the Illinois State Board of Education (last updated Feb. 1, 2021), demonstrates that 53 percent of Illinois students are learning remotely, 38 percent are enrolled in a blended remote learning model, and 10 percent are in person. We do not believe reaching a 95 percent threshold of in-person participation in testing is possible nor is it plausible.
- If we are able to get students to return for in-person testing, we would be losing many days of learning for required testing. For many of our districts, social distancing and occupancy limits dramatically limit the number of students we can have in a school and a classroom at a time thereby extending the number of days required for testing. Sadly, this reduces the already limited amount of time our teachers have with their students to engage in learning.

We understand that there may be a pending decision to ensure testing occurs, but that the reporting of data on a state report card will be waived. Again, we are not opposed to accountability or state report cards especially in normal times, but these are anything but normal. Rather, like our colleagues across the nation, we are working diligently to get a larger portion of students back into schools for in-person instruction, working to address the social and emotional, and academic, needs of our students which includes plans to address lost opportunities, getting

staff and community members vaccinated, and serving as a lifeline for so many members of our communities. Let us focus on those priorities rather than on the logistics of testing kids.

Please waive the requirement for federally mandated state assessments this year!

Board of Education Meeting February 2021 Principal's Report, Jeremy Schmidt

Student Registration

As the final registration push will be made in the coming weeks, school counselors are continuing to actively meet with freshman through juniors to register for next year's classes. With the complexities brought from limited students on campus throughout the year, registration meetings have been challenging for school counselors and will likely continue all the way through early to mid-March.

Following our virtual 8th Grade Enrollment presentation, administration has been closely watching the numbers of incoming freshmen course requests. As of February 11, over 320 freshmen have competed the course request process. This leaves approximately 100 students to complete the process in the coming weeks, and messaging via the website, emails, feeder schools, and individual phone calls will continue.

Administratively this is an important time of year for us, as all the course requests will ultimately build the master schedule. As soon as student requests are in, administration will begin to determine the necessary number of class sections and teachers needed to staff those sections.

February 12 Institute Day

Our February Institute Day will be a multifaceted day that covers a variety of professional development topics. The morning will focus on building-wide topics including: Crisis Planning, Cross-Discipline Instructional Discussions, an Equity Presentation, Emergency Plan Practice, and administrative presentations. The afternoon is being dedicated to departmental-level work and Professional Learning Team (PLT) collaboration.

Summer School

Summer School 2021 enrollment has been underway for the past month. The traditional enrichment course offerings like ComCon, Bulldog Seminar, Physical Education, Health, and Driver's Education will again be offered. Students enrolling and teachers applying are prepared to transition between in-person, blended, or remote instructional modes as dictated by conditions. Our goal is to have Summer School take place in person, and if the region stays in Phase 4, it is anticipated that in-person summer school will take place.

Credit recovery options for Summer School are also being offered. Credit recovery options are available for the vast majority of courses offered in our curriculum guide. Students who have earned failing grades, No Grade (NG), or Incompletes (I) qualify for credit recovery options. Additionally, the Leadership Team is exploring alternative possibilities for getting students caught up as well as alternative ways to further develop our Summer Academy bridge program for incoming freshmen. These options are being vetted for implementation if the Math Department, English Department, and feeder schools identify specific needs.

SAT Preparation Class

This year our SAT Preparation Class is being modified to reach more students and improve effectiveness. Moving away from the blended model of partially Grant teacher instruction and partially Khan Academy-generated coursework, Grant has partnered with Mrs. Sandy Martinez to teach Grant's 2021 SAT Prep Class. Mrs. Martinez is an Associate Professor from the College of Lake County and is a veteran test prep teacher with years of experience working with various test preparation companies in multiple area high schools. The curriculum will utilize the *College Board's Official SAT Study Guide* textbook. Through a combination of teacher led instruction, strategy and content acquisition, and individual practice, the course will provide students the resources, structure, and content to be successful on the SAT.

The course will be taught fully remotely using Schoology as the learning management platform. Meeting weekly, students will receive a total of 18 hours of instruction through six, three-hour classes. Four different times are being offered: Monday nights, Saturday afternoons, Sunday mornings, and Sunday afternoons. Courses begin the last week in February and end the second week in April.
